# What is the purpose of this update?

This document tells you how the Christian KiwiSaver Scheme Income Fund (the "Fund") has performed and what fees were charged. The document will help you to compare the Fund with other funds. The New Zealand Anglican Church Pension Board trading as Anglican Financial Care prepared this update in accordance with the Financial Markets Conduct Act 2013.

This information is not audited and may be updated.

#### Description of this fund

The Fund invests solely in income assets (fixed interest, mortgages and cash). It is designed to have a low risk profile and to appeal to investors close to retirement (who consider they may not have enough time to ride out investment highs or lows) or are more risk averse.

#### What are the risks of investing?

Risk indicator for the Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.



#### How has the fund performed?

#### Annual Return Graph

This shows the return after fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 31 March 2021.

There are currently no transaction individual action fees (e.g. establishment, contribution, withdrawal, fund switching) or other fees charged.

The total annual fund charges are calculated daily as a percentage of the net asset value of the Fund.

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor

Sarah had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges and tax were deducted of \$253.83 (that's 2.54% of her initial \$10,000). Sarah did not pay any other charges. This gives her a total return after tax of \$253.83 for the year.

- 1. The fee for investments in the Income Fund changed during the year from 1.0% to 0.8%. For the period 1 April to 30 September 2020 the fee was 1.0% and for the period 1 October 2020 to 31 March 2021 the fee was 0.8%.
- 2. In addition to the above fixed fee the Manager is entitled under the trust deed to be reimbursed from the Christian KiwiSaver Scheme for other costs and expenses, such as those that are irregular or extraordinary or cannot be reasonably known or estimated.
